Dear Shooter,

The 2010 Northern Rockies Machinegun and Cannon Shoot will be held on June 4th, 5th, and 6th.

The shoot is sponsored by the Wyoming NFA Shooters Club. Profits from the event are given to the Casper Mountain Volunteer Fire Department. Ground covers for your firing position are strongly encouraged to keep the Wyoming dust down and to facilitate clean-up. We will be utilizing aerial and reactive targets again as well as stationary targets. We anticipate the ability to use tracer and incendiary ammo. We will not be using vehicles as targets this year. The cattle were unable to digest the shards of plastic and metal left behind from all the prior targets. Adequate substitute targets are being planned.

Attending a shooters meeting remains **mandatory** before you can access the firing line and they will be held twice daily, one at 0730 and one at noon for late comers. There will also be an extra shooter's meeting on Thursday evening, June 3rd for those who want to attend. Again, no registered shooter will be permitted to get on the firing line until they have attended at least one shooter's meeting. Safety remains the major factor, and without this safety briefing, you are unsafe!

As many of you know, there was a tragic death of an 8 year old in 2008 at a gun shoot. This youngster was firing a mini-UZI. In response to this incident, we are going to ban the RENTAL of machinepistols and short machineguns that have an overall length with the stock folded of 18" or less. If there is a gun whose length is less than 18" with the stock folded but when extended is greater than 18", it is a banned rental gun. This removes such guns as a mini or micro UZI, an MP5K, or MAC. Full size Uzi's are OK. This does not prevent you from shooting your own firearm, but we do not want spectators firing these types of guns. Any questions about this should be directed to Stuart Ruben. This decision is made in the interest of public safety.

For those of you that need to fill out a 5320.20, the actual address is Garrett Ranch, 19415 South State Highway 487, Casper, WY 82604.

You may set up your space on Thursday, June 3rd. Enclosed are registration materials. Please feel free to tell your shooting friends who may not have received this letter to check out our web site to get a registration form (or copy the enclosed one for them). Fees for the weekend are \$200 per shooting spot which includes 1 shooter's badge, \$75 for each additional shooter's badge. Also, DVD videos of the 2007 shoot are still available for purchase (\$10 plus \$1 tax) and will be at the shoot. Tee shirts are available this year for \$15. Deadline for registration is May 1 so we can set the firing line.
